New legislation in the United Kingdom will ban people from receiving money or free

goods for writing positive reviews. Major tech companies will face large fines

for breaching the new consumer protection rules.

Kaitlin Woolley, associate professor of marketing, examines the psychological processes

underlying consumer motivation and has studied incentivized product reviews.

Woolley says:

'The vast majority of consumers rely on product reviews when making new purchases.

Consumers are more likely to buy products with positive reviews, and often cannot easily differentiate between real and fake reviews. In my research, I've

found people are influenced by positive reviews even if they are warned that such reviews were purchased by the company and thus artificially positive. This

is why it is necessary to implement policies to help regulate the review landscape.
